A tax benefit for people who worked full or part-time. This year there are new and expanded tax credits for low to moderate income workers.

If you are married, you must file as "married filing jointly". Investment income must be \$3,200 or less for the year. You and your dependants must have a Social Security Number that is valid for work. You must be a U.S. citizen or a resident alien ALL year in order to claim this credit.
